## **Overview**

power cable requires 6 inches of separation. The National Electrical Code establishes specific minimum distances when communications cables must run near power and light circuits. This safety zone also mitigates most EMI, and power induction issues. Unlike Power over Ethernet (PoE), which is limited by copper cable characteristics, PoF leverages optical fiber to overcome distance, electromagnetic interference, and safety constraints. However, the maximum transmission distance of PoF is not a single fixed number. Other than that you haven't provided much information, given. Underground cables are pulled in conduit that is buried underground, usually 1-1.2 meters (3-4 feet) deep to reduce the likelihood of accidentally being dug up. Fiber optic cables transmit data using pulses of light, making them entirely immune to electromagnetic interference. Consequently, fiber optic cables do not require the same minimum separation distances
