

# How long can a cable be without a cable tray



## Overview

TC-ER-rated cables can be installed in exposed runs outside the cable tray, up to 6 feet between the cable tray and connected equipment, and without conduit—provided that the cable is secured and protected from mechanical damage, per code. The primary rulebook used in the safe use of cable trays is NEC Article 392. This is a description of how to select, install, and support these metal or plastic frames, on which electrical wires are installed. You should consider it as a series of instructions that make the buildings resistant to. Although BS 7671 touches on the subject of cable supports, it does not detail specifically what these support distances should be. Clause 522-08-04 Where conductors or cables are not supported. Cable tray is the preferred wiring method for industrial facilities, data centers, and large commercial buildings where routing dozens or hundreds of cables through individual conduits would be impractical and expensive. NEC Article 392 governs cable tray installations, covering tray types, fill. Answer: No.
