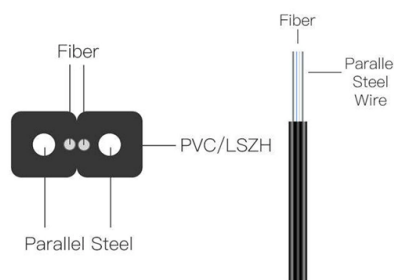


Regulations for the Use of Small Distribution Boxes on Construction Sites
