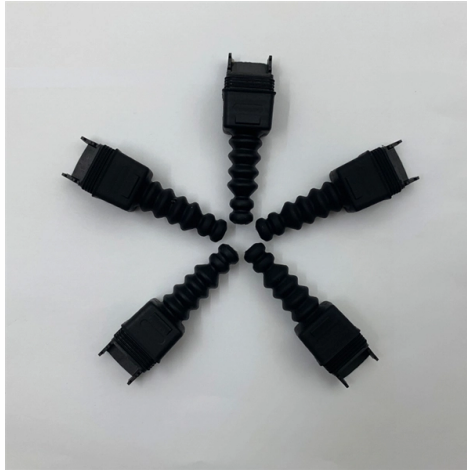


Site Requirements for Building Communication Towers
